A message from the BDA Northern Ireland Director



Tristen Kelso

I want to wish Kathryn every success for her 2026 Presidential year, taking over the reins from Derek Manson.

It really is testament to the dedication of our NI Branch Council officers that six of the top ten most booked BDA Branch and Section events over the past year were Northern Ireland Branch events.

It's also fitting that the primary focus of BDA during 2026-28 will be on Membership. We want to see our membership grow, and key to this is that every dentist recognises the immense value of everything that BDA does on their behalf. That work can only continue with the valued support of our members.

That same level of dedication is also reflected in the work of our BDA NI committees as they represent and advocate on behalf of all dentists in Northern Ireland.

Over the past twelve months our Community Dentists Committee has successfully highlighted key workforce issues impacting on the CDS, culminating in a BDA CDS Workforce Roundtable event in September.

Our Dental Practice Committee has fought vociferously to highlight the impact of increased National Insurance employer contributions on practices. Following a joint campaign with FPS colleagues, we are the only part of the UK where we succeeded in securing £2.5m of recurrent funding towards mitigating increased NI costs.

We've also secured a Cost of Service Review which is being undertaken by Prof. Ciaran O'Neill and will report in March to inform the future shape of General Dental Services here; and, following intense political lobbying by BDA, including two Assembly debates and multiple Health Committee briefings we secured £7m additional funding into General Dental Services.

Of course, much more needs to be done to secure adequate investment to stabilise GDS.

Our very active NI Hospital Dental Services Forum has also highlighted critical HDS workforce gaps directly to key decision-makers and has advocated on pay alongside BMA colleagues.

We've inputted into a review of Dental Nurse Training and gained recognition of both City and Guilds and NEBDN under the NI Apprenticeship scheme; we've engaged directly with the Health Minister on wider dental reform and investment, on student finance issues, DDRB and much more; and NI Council has deepened its local engagement with key bodies including our regulators on pertinent issues such as dental tourism.

We are pleased that a newly constituted 'Central Dental Advisory Committee' (CDAC) will meet in January to give strategic direction on issues connected with provision of dental services across NI. We commend our CDO for taking this important step.

2025 also saw Roz McMullan being honoured with an OBE for services to Mental Health and Wellbeing in the dentistry profession in Northern Ireland. Yet again, proof if needed of the immense commitment your BDA Northern Ireland representatives make on behalf of their colleagues and profession, every single day.

In 2026, I'm confident that here in Northern Ireland dentists will continue to step forward to serve and to lead on behalf of their colleagues and their profession in the name of BDA.

That's how we will move dentistry forward, and how we will grow our membership.

BDA Northern Ireland and National Committees

Democracy is at the heart of the BDA Northern Ireland Committees. Members are elected triennially to represent their peers and colleagues across Northern Ireland. They negotiate, lobby and develop policy on your behalf. They provide an important link, sharing knowledge and experience of front-line care to help inform these decision-making processes.

Northern Ireland Branch Council

President, elected officers and members work to create and deliver local high quality CPD lectures and dedicated social events for BDA members. It provides a fantastic opportunity to network, learn and develop professionally.

Northern Ireland Community

Dentists Committee represents dentists employed in community dental services across Northern Ireland. It is a decision making, craft committee which negotiates on contractual terms and conditions and lobbies on issues of importance to Community Dentistry.

Northern Ireland Council has representation from the chairs of NI GDS, CDS and HDS committees and Branch President, and feeds member issues to UK Council, ensuring they are heard at the highest BDA level. They discuss strategic cross-cutting issues impacting on dentistry in Northern Ireland such as dental amalgam, oral health, education and workforce issues

Northern Ireland Dental Practice

Committee represents dentists working in general practice across Northern Ireland. It is a decision-making, craft committee recognised by government to negotiate on contractual and policy issues on behalf of General Dental Practitioners and works closely with other stakeholder organisations to ensure members are represented.

Northern Ireland Hospital Dental

Services Forum represents dentists working in Hospital Dentistry across Northern Ireland. The forum also provides a channel of communication between hospital dental staff and BMA which leads negotiations on terms and conditions of service, and lobbies on issues of importance in Hospital Dentistry. The NI HDS Forum is also represented on the BDA Central Committee for Hospital Dental Services by three representatives, comprising one each Consultant, SAS and Resident representative.

BDA Principal Executive Committee

is the highest decision-making body within the BDA. It sets the strategic direction of the organisation and is made up of Directors elected directly by the membership.

UK Council Representatives from the four country councils meet as the UK Council, to discuss matters of common concern brought by the various local bodies. The UK Council has an important role on behalf of members in holding the PEC to account on behalf of members.
